This notice is being issued for Online Registration & uploading of documents, Documents verification and Application Form Confirmation at College of Engineering Pune for admissions to First Year of Full Time Degree Course in B.Planning in College of Engineering Pune for the Academic Year 2019-20 in the Maharashtra State.

The admission Process will be conducted through counseling round at College of Engineering Pune. The details are as below.

(i) The candidate should be an Indian National; (ii) Passed HSC or its equivalent examination with subjects Physics and Mathematics as compulsory subjects along with one of the Chemistry or Engineering Drawing or Computer Science or Biology or Technical Vocational subject and obtained at least 50 % marks (at least 45 % marks in case of candidates of Backward class categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together; (iii) The candidate should have appeared in all the subjects and obtained non zero score in the MHT-CET 2019 conducted by the Competent Authority.	(i) The candidate should be an Indian National; (ii) Passed HSC or its equivalent examination with subjects Physics and Mathematics as compulsory subjects along with one of the Chemistry or Engineering Drawing or Computer Science or Biology or Technical Vocational subject and obtained at least 50 % marks (at least 45 % marks in case of candidates of Backward class categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together (iii) The candidate should have obtained non zero positive score in JEE Main Paper II or the candidate should have appeared in all the subjects in MHT-CET 2019 and should have obtained non zero score in CET conducted by the Competent Authority. However preference shall be given to the candidate obtaining non zero positive score in JEE (Main) Paper II over the candidates who have obtained non zero score in MHT-CET 2019.	(i) Passed HSC or its equivalent examination with subjects Physics and Mathematics as compulsory subjects along with one of the Chemistry or Engineering Drawing or Computer Science or Biology or Technical Vocational Subject and obtained at least 50 % marks in the above subjects taken together; (ii) Any other criterion declared from time to time by the appropriate authority as defined under the Act.

Online Registration for Admission: -

- 1.1 The candidates should apply online on mahacet.org as perschedule.
- 1.2 Candidates who have registered for MHT-CET 2019 are not required to pay any fees for registration for admission. However other candidates who have obtained score which is valid for admission in academic year 2019-20 in JEE (Main) Paper II and have not registered for MHT-CET 2019 are required to pay fees as given below only by Credit Card/ Debit Card/ Net Banking etc. through Online mode. Fees paid is non-refundable. (No other mode of payment shall be permitted.)

- All types of candidates aspiring for admission shall register, get Documents Verified & Application Form confirmed at College of Engineering Pune. Such eligible registered candidates shall be considered for admission through counselling round conducted at College of Engineering Pune.
- Candidate shall carry printed copy of Application Form, Original documents and one set of Xerox copies of the required documents. College of Engineering Pune shall verify all documents from Original.
- Reserved category candidates must produce caste validity certificate at the time of counseling round. SEBC category candidates do not required to produce the caste validity certificate at the time counseling round.

Important Instructions for candidate:

- The candidates are required to produce the documents in original for verification and Confirmation of Application Form at College of Engineering Pune. It is mandatory on the candidate's part to produce all original documents in support of the claim made by the candidate in the application form. Candidates are advised to keep the necessary documents ready at the time of Documents verification stage as per the notified schedule.
- If candidates fail to confirm online filled application form at College of Engineering Pune, then
 such applications will be rejected and name of such candidates will not appear in the merit list(s)
 prepared for the purpose of Admission through counseling round.
- 3. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC, SBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All Backward Class candidates excluding SC & ST shall produce Non Creamy Layer certificate valid up to 31st March 2020. If such candidates fail to produce the Caste/Tribe validity and Non Creamy Layer certificate at the time of verification at College of Engineering Pune, then such candidates will be treated as GENERAL category candidates for admission.
- 4. EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section.
- Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during documents verification stage shall have to pay difference of fee of 200/- at the College of Engineering Pune through online mode only.
