Admission Process for First Year Engineering (B.TechProgrammes) for AY 2022-23 at COEP Technological University

Admissions for UG Programs at COEP Technological University for AY-2022-23:

There is a CHANGE in the Intake capacity of all B.Tech (UG) programs at COEP Technological University, with effect from AY 2022-23 i.e. this year. There is INCREASE in INTAKE by 25% in each of the B.Tech Branches. However, the original 100% seats are reserved and available for Maharashtra State candidates (Maharashtra Domicile), exactly as per previous year, on the basis of their merit/scores in the State's MHT-CET-2022, with other eligibility criteria as decided by the State Government of Maharashtra, with no change in them when compared to the previous year. The additional (increased) 25% seats in each of the B.Tech programs are being offered to the All India Candidates, on the basis of their merit/score in the national level JEE (Mains) Examination-2022. The Maharashtra domiciled candidates, however, can compete in this quota also.

For example, the branches such as Computer Engineering or Mechanical Engineering at COEP, which had intake capacity of 120 last year, will now have 120 + 25% of 120 = 120 + 30 = 150 seats from this year. The original intake of 120 will be reserved for Maharashtra candidates based on their MHCET Scores exactly like last year. The additional 30 seats will be available for All India candidates, based on their JEE (Mains) Scores, the Maharashtra candidates can also compete in this quota.

For other B.Tech branches with previous 60 intake, will have an additional intake of 15 seats (thus total intake of 60 + 15 = 75), with these 15 seats available for All India candidates, and the original 60 seats reserved for Maharashtra candidates.

The supernumerary (over and above) quotais applicable for the students belonging to the categories of CIWG, NRI, FN, OCI, PIOs as per the rules of Government of Maharashtra and other regulatory bodies.
