iii) Preference shall be given to the Candidates appeared for MAH B. Planning-CET 2023. Seats remaining vacant after the CAP rounds, will be open for other candidates who have applied.

### For Maharashtra Candidature Candidates and All India Candidature Candidates

- i) The Candidate should be an Indian National;
- ii) Passed Bachelor Degree in Planning or Architecture or Civil Engineering or Master Degree of Geography or Economics or Social Sciences or equivalent Degree with at least 50% marks (at least 45% marks in case of candidates of Backward Class categories, Economically weaker section and Persons with Disability category belonging to Maharashtra State);
- iii) Obtained non zero positive score in Common Entrance Exam for Design (CEED) conducted by Indian Institute of Technology; or
- iv) Obtained Qualified score in Graduates Aptitude Test in Engineering (GATE) conducted by Indian Institute of Technology and valid for the current academic year or Obtained non-Qualified marks in Graduates Aptitude Test in Engineering (GATE) conducted by Indian Institute of Technology for the current academic year. However, preference shall be given to the CEED appeared candidate over the GATE appeared candidates; or
