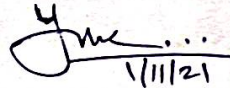
The candidates who want to be a part of the association should have a CGPA of more than 7.5 and possess no current backlogs.

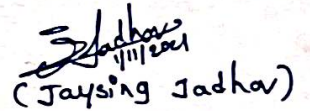
For the various activities of the association, request you to allocate funds from the Department Development Fund (DDF).

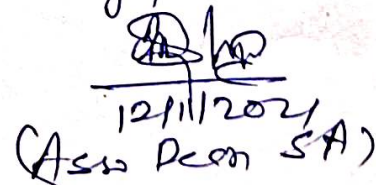
