Applicant must bring all the original certificates at the time of selection process for the purpose of verification, along with one set of photocopies.

General Information / details about the post

1. The appointed person shall have no claim of appointment / absorption in Funding Agency or in COE Pune.
2. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
3. The qualification prescribed should have been obtained from recognized Universities / Institutions.
4. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle candidates to be called for interview. Where number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates.
