Admission Notification for Vacant Seats after CAP for First Year B Planning Program - 2023-24

- 1. The admissions for Vacant Seats after CAP for First Year B. Planning Program 2023-24 at COEP Technological University, Pune will be conducted by Direct Counseling Round as per *Inter-Se-Merit* of Candidates who have applied to the University as per admission notification dated 5th July 2023.
- Candidates are required to report in person on Saturday, 5th August 2023 up to 10.00 AM for admission to Department of Planning, COEP Technological University, Shivajinagar, Pune, Maharashtra.
- 3. These admissions will be made strictly in the order of *Inter-Se-Merit* amongst the candidates who report in person for admission to COEP Technological University, Pune for **Vacant Seats after CAP** at that moment.
- 4. The candidate will lose the claim to participate in the admission counseling process if he/she fails to produce all the applicable original documents at the time of document verification during the Counseling Round.
- 5. Candidates must carry two sets of photocopies (xerox copies) of all original documents (self-attested), as mentioned in the brochure for the Academic Year 2023-24. Candidates must also carry two passport size color photographs while reporting for admission.
- 6. In case a candidate has taken admission elsewhere, he/she will be required to submit/produce the Original Fee Receipt and Acknowledgement. The candidate should submit an undertaking stating that he/she will submit original documents within five working days from the date of reporting.
- 7. The seat allotment will be carried out based on the vacancy status at that point. Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats.
- 8. Candidates are advised to be present in the Counseling Hall and wait for their turn as per *Inter-Se-Merit*. If a candidate is found unavailable when called, the next candidate on the merit rank would be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.
- 9. Suppose a candidate of higher merit reports late during the process of counseling. In that case, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that moment. The decision of the admission center in-charge shall be final and binding.

- 10. At the time of seat allotment by counseling, the candidate is required to submit "Requisition for Seat Allotment." The Seat Acceptance Fee shall be Rs.1,000/- for all Candidates which is an additional fee other than Application Fee paid earlier. This fee shall be treated as non-refundable, nontransferable processing fee.
- 11. Confirmation of the allotted seat to the candidate is subject to the payment of requisite Admission Fees and submission of applicable original documents and Anti-ragging Form immediately in online mode. This candidate confirms admission through the acceptance of the allotted seat at COEP Technological University, Pune.
- 12. All fees are to be paid via **Online Mode** (SBI Collect, NEFT, UPI, etc.) or **Demand Draft** in the name of "COEP Technological University Pune" as per following details:

- 13. If a candidate fails to pay the requisite Institute Admission Fee at the time of seat allotment, such candidature will be withdrawn, and the seat will be allotted to the next candidate on the merit list. Payment through cash / cheque will not be accepted under any circumstances.
