## **Announcement of Admission Round-2 and Schedule for CIWGC, OCI/PIO/FN and NRI Candidates.**

**Instructions for Admission through counseling round-2 to First Year of Under Graduate Technical Courses in Engineering and Technology as well as B. Planning program for CIWGC, OCI/PIO/FN and NRI Candidates at COEP Technological University (COEP Tech) Pune for the Academic Year 2022-23.**

The stages of admission process are prepared following the Information Brochure {Academic Year 2022-23} for admissions to Full Time Professional Undergraduate Technical Courses (Refer Information Brochure page number seven clause numbers 7. Allocation of Seats – sub clause number 5- Supernumerary Seats as follows)

### **(a) OCI/ PIO, Foreign Students and the Children of Indian Workers in Gulf Countries (CIWGC) Candidates**

- (i) The Candidates having candidature as given in 5(5) of Information Brochure and the Children of Indian Workers in Gulf Countries shall be eligible for these supernumerary seats.
- (ii) These seats shall be subject to the maximum of 15% of the Sanctioned Intake seats

Out of 15% seats,

- a) One third shall be reserved for the Children of Indian Workers in Gulf Countries (CIWGC)

and

- b) Two third seats shall be reserved for OCI / PIO or Foreign Students candidates or as prescribed by the Appropriate Authority, from time to time.

Provided that, if seats in a course reserved for Children of Indian Workers in Gulf Countries remain vacant, then such vacant seats shall be filled in from the candidates of OCI, PIO or Foreign Students and if seats reserved for candidates of OCI, PIO or Foreign Students remain vacant then such vacant seats shall be filled in from the children of Indian Workers in Gulf Countries.

Provided further that, if any vacant seats remain in any of the above quota, it may be filled in from NRI Candidature Candidates by the Institute provided it has prior approval from the appropriate authority for the NRI seats.

1. All eligible and interested Candidates or close relative of the candidate with undertaking signed by the candidate for the representation of candidate, should report to the Main Auditorium of the institute for the admission process on **9<sup>th</sup> November 2022 at 11.00 AM** for counseling round along with prescribed institute admission fees as mentioned in Table.

Candidate or close relative of the candidate should produce all the essential original documents at the time of admission process. Also an undertaking stating that *“The information given by me in the application is true to the best of my knowledge & belief and if at later stage, it is found that I have furnished wrong information and/or submitted false certificate(s), I am aware that my admission will stand cancelled and fees paid by me will be forfeited. Further, I will be subject to legal and/or penal action as per the provisions of the law”* should be submitted. If the candidate or his/ her close relative, with authority letter of candidate, fails to report in person to the institute for the admission for counseling round-2 on 9th November 2022 at 11.00 AM, his/her claim on the seats shall stand cancelled.

2. Candidates whose names appear in the confirmation list, declared by the Common Entrance Test (CET) Cell Maharashtra State, Mumbai for Admission to First Year of Under Graduate Technical Courses in Engineering and Technology for CIWGC, OCI/PIO/FN and NRI are only eligible to appear for admission process to the First Year of Under Graduate Technical Courses in Engineering and Technology under CIWGC, OCI/PIO/FN and NRI category at COEP Tech. However, for B. planning program for CIWGC, OCI/PIO/FN and NRI category students need apply afresh **through E-Mail to [fyadmission2022-23@coep.ac.in](mailto:fyadmission2022-23@coep.ac.in)**

3. Seats available for stage1-round-2 for Admission to First Year of Under Graduate Technical programmes in Engineering and Technology as well as B. Planning programme for CIWGC, OCI/PIO/FN and NRI candidates at COEP Tech. for the Academic Year 2022-23 are depicted in Table 1A and 1B.

4. For admission to COEP Tech., candidate is required to pay the **non-refundable** admission processing fee of Rs. 10,000/- (Rupees Ten Thousand Only) per application form for CIWGC, OCI/PIO/FN and NRI through SBI collect in online platform ([State Bank Collect \(onlinesbi.sbi\)](https://www.onlinesbi.sbi)) only. 5. Separate additional application form along with separate admission processing fee paid receipt (PDF Generated) should be sent through email to [fyadmission2022-23@coep.ac.in](mailto:fyadmission2022-23@coep.ac.in) by CIWGC candidates if they wish to be considered in OCI/PIO/FN and NRI category as well.

6. At any later stage, if a candidate wishes to withdraw from the admission process the admission processing fees will not be refunded under any circumstances and no such claims will be entertained.
7. Schedule of Counseling round-2 is mentioned in Table 2.
  - i. All the admissions to F.Y. B.Tech. programmes of AY 2022-23 will be made strictly in the order of inter-se merit from amongst the candidates whose name appears in the confirmation list as declared by the Common Entrance Test (CET) Cell Maharashtra State, Mumbai (except B.Planning program) and who have submitted scanned copies of all the essential original documents through email at [fyadmission2022-23@coep.ac.in](mailto:fyadmission2022-23@coep.ac.in)
  - ii. All the scanned copies of original documents should be clearly visible and legible. List of all the essential documents is as indicated in the acknowledgement received from verifying authority SPCE, Mumbai and mentioned in Maharashtra State Common Entrance Test Cell Information Brochure for Academic Year 2022-23.
  - iii. Attach the scanned copy of application verification acknowledgement received from verifying authority SPCE, Mumbai along with Application form (**Annexure – I**)
  - iv. Also attach the receipt of admission processing fee of Rs.10, 000/- (Rupees Ten Thousand Only) paid through SBI collect. Those who have already paid the processing fee of Rs.10, 000/- need not pay again.
8. For B. Planning program COEP Tech. will publish its separate merit list, for those who apply afresh to COEP Tech. for admission under CIWGC, OCI/PIO/FN and NRI category for AY 2022-23.
9. The candidate will lose his/her claim to participate in the admission counseling process if he/she fails to submit all the required original documents at the time of document verification process during counseling round on **9<sup>th</sup> November 2022**. In case a candidate has taken admission elsewhere, he/she will be required to submit copy of admissions allotment letter and / or proof stating that the original documents are retained by the respective institute for the admission purpose.
10. The details of the requisite admission fees for first year of the undergraduate program applicable to the respective category (CIWGC, OCI/PIO/FN and NRI) is given in Table 3 of this document.

11. Candidate has to pay requisite institute admission fees (as per his/her category status) immediately at the time of admission process on 9<sup>th</sup> of November 2022 to confirm his/her admission if the seat is allotted. The Fees applicable (as per his/her category status) is mentioned in Table 3, otherwise his/her candidature will be annulled for the respective stage.
12. These admissions will be made strictly in the order of inter-se merit. The seat allotment will be carried out based on the vacancy status at the moment at which candidate presents himself / herself or his/her authorized representative.
13. For admission in NRI and FN category, candidate must pay institute admission fee in USD through demand draft only drawn in favour of "Director College of Engineering Pune".
14. CIWGC, FN and NRI Candidates seeking admission to OCI/PIO/FN, NRI category are required to pay the requisite Institute admission fee in USD through demand draft only drawn in favour of "Director College of Engineering Pune" on 9<sup>th</sup> November 2022 during admission process. However, OCI/PIO category students can pay their College fees in Indian rupees (INR) at the conversion rate applicable at the time of confirmation of admission.
  - CIWGC Candidates seeking admission to CIWGC category are required to pay the requisite Institute admission fee in **INR** through demand draft only drawn in favour of "Director College of Engineering Pune". In subsequent stages of admission counseling round on 9<sup>th</sup> November 2022
  - If a CIWGC candidate is seeking admission to unclaimed seats of OCI/PIO/FN category, such candidate will have to pay the requisite institute admission fee as applicable to respective OCI/PIO/FN category of seat through demand draft only, drawn in favour of "Director College of Engineering Pune".
  - However, if a OCI/PIO/FN category candidate is seeking admission to unclaimed seats of CIWGC category, such candidate will have to pay the requisite institute admission fee as applicable to respective OCI/PIO/FN category of seat through demand draft only, drawn in favour of "Director College of Engineering Pune".
  - However, if a NRI category candidate is seeking admission to unclaimed seats of CIWGC category or OCI/PIO/FN category, such candidate will have to pay the requisite institute admission fee as applicable to respective NRI category of seat through demand draft only, drawn in favour of "Director College of Engineering Pune".

15. The candidate who fails to report to the institute for the admission to verify essential original documents at COEP Tech. and pay the institute admission fees in demand draft drawn in favour of "Director College of Engineering Pune", his/her claim on the allotted seat shall stand cancelled.
16. Confirmation of seat will be on immediate payment of institute admission fees at the time of accepting the offered seat by the candidate. Candidate will be issued an allotment letter thereafter. The allotted programme of study is final, however it may be altered in the subsequent stages of allotment depending upon the vacancy and the candidate's choice on inter-se merit only.
17. The admitted candidate should submit an online anti-ragging affidavit after confirming admission at Institute on either of the following links: [www.antiragging.in](http://www.antiragging.in) or [www.amanmovement.org](http://www.amanmovement.org).
18. In case of cancellation of confirmed admission at later stage, Institute admission fees paid by the candidate are non-refundable under any circumstances.
19. Only those candidates who have submitted application to COEP Tech. **through E-Mail** to [fvadmission2022-23@coep.ac.in](mailto:fvadmission2022-23@coep.ac.in) up to the last date along with admission processing fees will be considered for stage I, II and III of the counseling round mentioned below.

### **Stages of admission:**

- I) **Stage I** will be conducted only for OCI / PIO / Foreign National Candidates and CIWGC in respective candidature/category based on the seats available in a particular program / discipline to the candidate during the counseling round as per inter-se merit.
  
- II) **Stage II-** if seat(s) remains vacant in CIWGC or OCI / PIO / Foreign National category after stage I, then vacant seats in both these categories will be clubbed together and combined round will be conducted only for CIWGC and OCI / PIO / Foreign National category candidates as per inter-se merit.
  
- III) **Stage III-** if seats remain vacant after stage II then vacant seats in both categories will be clubbed together and round will be conducted for NRI candidates as per inter-se merit.

Seat falling vacant after stage 3 of 2<sup>nd</sup> counseling round of 9<sup>th</sup> November 2022 may be filled as per above procedure in next counseling round as notified on the institute website. Notification for the next round shall be made available on the institute website [www.coep.org.in](http://www.coep.org.in). All seats remaining vacant after counseling rounds will continue to remain vacant after admission cutoff date declared by competent authority as these seats are supernumerary in nature.

- Fees for the Academic year 2022-23 are subject to revision which will be in accordance with the notification of the Govt. of Maharashtra, that will be announced in due course of time.
- For those students who pay full fees, on receiving Government notification, the excess amount paid by the student will be refunded.
- For those students who pay fees in installments, on receiving Government notification, the subsequent installment amount will be reduced accordingly.
