ADMISSION NOTICE FOR FIRST YEAR B. PLANNING PROGRAMME FOR THE ACADEMIC YEAR 2022-23

(On behalf of CET Cell of Government of Maharashtra)

This notice is being issued for Online Registration, Scanning & uploading of documents, offline Documents Verification and Application Form Confirmation at Institute. Paying seat acceptance fees in online mode (through SBI Collect) for confirmation of admission, reporting to COEP Technological University (COEP Tech) by candidates aspiring for admissions to First Year Full-time course in B. Planning program at COEP Technological University for the Academic Year 2022-23.

The candidate shall fill and submit the application form online.

Process of application: The Candidate shall register online on COEP Tech website (<u>www.coep.org.in</u>), the candidate shall fill and submit online application form and upload the required documents from anywhere through the computer connected to internet and he/she has to visit personally for verification and confirmation of the application form to the Institute. His/her application and documents shall be verified and confirmed by COEP Tech, Scrutiny Center through offline mode only.

- (i) The Candidate should be an Indian National;
- (ii) The candidate should have passed 10+2 examination with Mathematics as compulsory subject along with any two subjects out of Physics or Chemistry or Computer Science or Electronics or Information Technology or Biology or Informatics Practices or Biotechnology or Technical Vocational Agriculture subject or Studies or Business Engineering Graphics Entrepreneurship and obtained at least 45 % marks in aggregate (at least 40 % marks in aggregate in case of Reserved categories, Economically Weaker Section and Persons with Disability category candidates belonging to Maharashtra State);
- (iii) The Candidate should have obtained non zero score in the MAH- B. Planning CET 2022.
- (2) All India Candidature Candidates and Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant Candidature Candidates
 - (i) The Candidate should be an Indian National;
 - (ii) The candidate should have passed 10+2 examination with Mathematics as compulsory subject along with any two subjects out of Physics or Chemistry or Computer Science or Electronics or Information Technology or Biology or Informatics Practices or Biotechnology or Technical Vocational subject or Agriculture or Engineering Graphics or Business Studies or Entrepreneurship and

- obtained at least 45 % marks in aggregate (at least 40 % marks in aggregate in case of Reserved categories, Economically Weaker Section and Persons with Disability category candidates belonging to Maharashtra State):
- (iii)The Candidate should have obtained non zero positive score in JEE (Main) B. Planning or the Candidate should have obtained non zero score in MAH B. Planning-CET 2022. However, preference shall be given to the Candidate obtaining non zero positive score in JEE (Main) B. Planning over the Candidates who have obtained non zero score in MAH- B. Planning-CET 2022.

(3) NRI / OCI / PIO, Children of Indian workers in the Gulf countries and Foreign National Candidature Candidates

- (i) The candidate should have passed 10+2 examination with Mathematics as compulsory subject along with any two subjects out of Physics or Chemistry or Computer Science or Electronics or Information Technology or Biology or Informatics Practices or Biotechnology or Technical Vocational subject or Agriculture or Engineering Graphics or Business Studies or Entrepreneurship and obtained at least 45% marks in aggregate;
 - (ii) Any other criterion declared from time to time by the appropriate authority as defined under the Act.

Important Instructions for candidates:

- All the rules and regulations of admission for the academic year 2022-23 will be in accordance and governed by information brochure for full time professional undergraduate technical courses published on CET Cell of Government of Maharashtra (http://cetcell.mahacet.org/).
- 2. If candidates fail to submit online application on COEP Tech website, then such applications will be considered and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission.
- 3. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC, SBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe

Validity Certificate". All Backward Class candidates excluding SC & ST shall produce Non Creamy Layer certificate valid up to 31st March 2023. If such candidates fail to produce the original certificate or receipt of Caste/Tribe validity certificate, Non Creamy Layer certificate and EWS certificate issued by competent authority at the time of verification by E-Scrutiny center, then such candidates will be treated as GENERAL category candidates for Admissions.

- **4.** EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section (proforma V-page 61 of CET CELL admission information brochure).
- 5. Candidates will get the Receipt-cum-Acknowledgement through their registered email after submission of application through the link provided on COEP Tech website. Applications received after the last date from such candidates will be summarily rejected and no correspondence will be entertained in this regard.
- 6. Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during E-documents verification stage shall have to pay difference of fee of Rs. 200/- through online mode only and such candidates will be considered as OPEN category candidates.
- 7. Preparation of Merit List & Centralised Admission Process CAP stages will be followed as per the Information Brochure for Admission to Under Graduate Technical Courses (2022-23).
- 8. A Candidate who has been allotted a provisional seat shall confirm the seat by reporting at COEP Technological University. Non-Confirmation/ Non-reporting by candidates for the provisional allotment will be treated as cancellation of allotment to the particular seat and will be shown as vacant in subsequent allotment round.
- 9. The Seat Acceptance Fee shall be Rs.1,000/- for all Candidates which is an additional fee to registration fee paid earlier. This fee shall be treated as non-refundable, non-transferable processing fee. The Seat Acceptance fee is to be paid through SBI Collect payment portal only.
- 10. As per the allotment, seat will be confirmed by COEP Tech after verification of the original documents and ensuring that the Candidate meets all the eligibility norms and the requisite fee by the COEP Tech. The admission in-charge of COEP Tech shall issue the Online Receipt of admission confirmation to the candidate.
- 11. The SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC and EWS Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non Creamy Layer Certificate, EWS Certificate as applicable to these categories during the document verification and confirmation period should scan and submit Caste/ Tribe Validity Certificate, Non Creamy Layer Certificate, EWS Certificate at the time of payment of seat acceptance fee and submit original certificate at COEP Tech institute on or before reporting to the admission to COEP Tech, otherwise these candidates shall be considered as Open category candidates and their allotment, if any, shall be cancelled in that category.
