At the outset, the chairman of BOS & HOD welcomes the member for attending the Board of studies meeting. The Chairman further expressed special thanks to all the members for spacing the time from their busy schedule to attend the meeting. After that agenda items were taken up and board decided/ recommended as under

The following points on the agenda were discussed in the following sequence:

- 1. Curriculum of Third Year B. Tech (Civil)
- 2. Content of courses for B. Tech Civil Honors
- 3. Content of courses for Minor in Civil Engineering
- 4. Any other point with permission of the chair

1. Curriculum of Third Year B. Tech (Civil)

- 1. Revised structure from SY to Final B. Tech Civil including Honors and Minor degree was discussed. Total credits are reduced from 180 to 170 therefore some courses are combined together. Prof. Jothiprakash said that reduction in course content and credits affected learning of students negatively.
- ii. Prof. Jothiprakash mentioned that student joined first year (knowing total credits of 180) is now taking 170 credits to complete B. Tech and will get honor if 4 additional courses are done, is not justifiable. Prof. Jothiprakash strongly suggested not tampering structure given in first year for that batch.
- 2. Even to ILOE allotment, CGPA criteria would be injustice to Civil Engineering Students. Hence baskets of ILOE of equal difficulty level should be offered.
- 3. Revision of curriculum is required to address higher study, Industry needs and Entrepreneurship development. Therefore while framing syllabi, due consideration should be given to syllabi of competitive exams viz. GATE, IES, MPSC, etc.
- 4. Alumni members requested to take industrial requirement into account while revising curriculum and opined that too many Mathematics courses are not required for regular degree.
- 5. Engineering Law must be offered at Institute level.

2. Curriculum of Second Year B. Tech (Civil)

Curriculum of SY B. Tech Civil was discussed. Liberal Learning Course is shifted to SY and TY level. When two courses are clubbed together, one has to check that students are able to absorb lot of concepts in one semester.

3. Course requirement for B. Tech Civil Honors

Minimum CGPA required to enroll for Honors was discussed and students should be encouraged to opt for Honors. Department should have verticals in Structural Engineering, Geotechnical Engineering, Water Resources Engineering, etc. Once registered for Honors, methodology to check academic performance of students should be developed.

4. Course requirement for Minor in Civil Engineering

There should be minimum 5 students enrolled for minor degree in Civil Engineering.
